NOTICE FOR EXHUMATION OF GRAVES AT CHOA CHU KANG MUSLIM CEMETERY (PHASE 8)

AFFECTED GRAVES AT BLOCKS 10, 11, 12, 13, 14, 15, 16, 18, 21 AND 22

- Registration for the exhumation of graves at Choa Chu Kang Muslim Cemetery Phase 8 is currently underway.
- Family members have been invited to claim the remains of their Next-of-Kin (“Principal Deceased”) buried at Blocks 10, 11, 12, 13, 14, 15, 16, 18, 21 and 22.

- The deadline for registration is on **12 September 2022**.

NOTICE FOR OBJECTION EXHUMATION OF GRAVES AT CHOA CHU KANG MUSLIM CEMETERY (PHASE 8)

IN CONNECTION WITH GRAVES OUTSIDE BLOCKS 10, 11, 12, 13, 14, 15, 16, 18, 21 AND 22 (“SUPPLEMENTARY GRAVES”)

- For this exhumation programme, family members are also allowed to claim the remains for graves located outside Blocks 10 to 16, 18, 21 and 22 (supplementary graves) provided that they have been buried at Choa Chu Kang Muslim Cemetery for at least 15 years prior to 12 September 2022.
- The list of claimed supplementary graves will be made known to the public and uploaded on the website as shown in the table below. Family members may object to claims listed. All objections are to be submitted no later than 26 August 2022 and 3 October 2022 respectively. Objections submitted after these dates will not be accepted.
